RESOLUTION NO. 2014-057

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BREA PROHIBITING VEHICLE PARKING AND AUTHORIZING THE ESTABLISHMENT OF PREFERENTIAL PARKING PRIVILEGES FOR RESIDENTS OF THE ASH STREET COTTAGE HOMEOWNERS ASSOCIATION.

A. RECITALS.


- (i) The City of Brea has received a petition indicating that 73 percent of the households within Ash Street Cottages Homeowners Association support implementation of preferential parking privileges for residents in this community; and
- (ii) The Traffic Committee considered this item and recommended establishment of a no-parking zone with preferential parking privileges, by permit only, for residents of this community, to include the following public streets: Ash Street between Brea Boulevard on the east and Madrona Avenue on the west; Madrona Avenue from 175 South Madrona Avenue structure entrance on the south to Ash Street on the north; Walnut Avenue from 101 South Brea Boulevard structure entrance on the south to Ash Street on the north, west side of Walnut only; and
- (iii) Section 22507 of the California Vehicle Code permits local authorities to designate certain streets upon which preferential parking privileges by permit are given to residents adjacent or in close proximity to the streets for their use and the use of their guests; and
- (iv) The City Council concurs with the findings and recommendations of the Traffic Committee regarding these parking restrictions.

B. RESOLUTION

NOW, **THEREFORE**, be it is found, determined and resolved by the City Council of the City of Brea as follows:

- 1. Vehicle parking is prohibited on Ash Street between Brea Boulevard on the east and Madrona Avenue on the west; Madrona Avenue from 175 South Madrona Avenue structure entrance on the south to Ash Street on the north; Walnut Avenue from 101 South Brea Boulevard structure entrance on the south to Ash Street on the north, west side of Walnut only, except for residents and their guests who clearly display parking permits issued by the City of Brea when parking their vehicles on these described streets.
- 2. The City Traffic Engineer shall cause appropriate signs to be installed on the above described streets, of such size, shape, and color as to be readily legible during daylight hours from a distance of 100 feet, to the effect that vehicle parking is prohibited on said streets except by City permit.
- 3. The Community Development Department shall issue parking permits to the residents on the above described streets in accordance with City of Brea residential permit guidelines. Residents of the above described neighborhood may issue temporary parking permits which are valid for 24 hours to their guests and visitors.
- 4. Parking permits shall be displayed in vehicles that are parked on the above described streets in accordance with the City of Brea residential permit guidelines.
- 5. The Chief of Police shall cause enforcement of these parking restrictions upon the completion of the installation of the aforementioned signs.
 - 6. The City Clerk shall certify to the adoption of this Resolution.
